Before that staggering purchase the ceiling had been set in 2007 by Ron Barron's purchase of the deMenil property also on Further Lane in East Hampton Village for \$103M. In fact, it has been nearly 8 years since the #1 place was near that level.

One interesting fact on this report is that 7 of the highest priced home sales were in Southampton Village.

If the high end is on a 7 year cycle we will need to wait until 2021 before we see the 2014 ceiling shattered.
